Ethics Committee Chair Lee Tarpley and Special Projects Director Susan Chapman presented the updated ASA, CSSA, SSSA Ethics Statement seeking feedback from board members before presenting it to the full membership for feedback. It will replace the former SSSA Ethics Statement, last updated in 1999. Board feedback included:

- Broadening the statement to be more inclusive for non-profits, industry, those who are not certified and non-academics/non-researchers to ensure they are reflected in this statement
- Suggest referencing on the document that a CCA and CPSS Code of Ethics exists
- The committee will not be revising the CPSS Ethics Statement & Complaint Investigation Procedure
- The committee will work on a separate Code of Conduct and will reference the Statement of Ethics
