#### **Reviewing Applications**

# **Policy Manual**

Board encouraged to review the manual further and will be discussed on next meeting.

#### **Exam changes**

Will allow people to take Soils Fundamentals exam in three sections by subject matter (soil chemistry and fertility; soil physics and soil classification morphology and genesis; soil biology and land use) instead of one large section

-Would pay more in proctoring fees if they take it in sections due to having to pay for three proctoring sessions vs. one session

-Needs to take all sections within 6 months; can retake sections if needed

#### Marketing

#### Anything else?

Onsite wastewater idea:

Many states do not have enough soil scientists that do onsite wastewater septic system work.

Creating a national wastewater license?

-Suggested requirements: need to take a section (suggested soil physics and classification morphology) of the Fundamentals Exam in order to get licensure, at least a 2-year degree or sufficient experience, and some sort of state/local training, licensing, or class.

-Would help bolster the SSSA program and would help the states gain numbers of certified professionals that work on site

-Big market to tap into
