# **SWCS Liaison Report (Jeff Strock)**

The 16<sup>th</sup> SWCS-SSSA joint symposium was held on Tuesday (11/17) on the topic of long-term agricultural research. The symposium served as an update from a similar symposium 26 years ago. Attendance was good, with approximately 80 attendees. There were 22 volunteered posters associated with the joint symposium.

A similar symposium was held at the SWCS annual meeting in July, with approximately 75 attendees.

A special issue on long-term agricultural research is being explored for potential publication in *Journal of Soil and Water Conservation*.

Input is sought for symposium topics for next year's SWCS and SSSA annual meetings. Topics should consider the broad themes of each meeting (e.g., resilience, water and food security, etc.).

#### **Review of Sessions/Symposia**

- Monday: Agroecosystem resilience, Bioenergy cropping systems, Soil C and N dynamics
- Tuesday: Long-term agricultural research, Restoring soil health (symposium; very well attended),
   Soil and water management and conservation, Soils and human health (symposium; also well attended).
- Wednesday: Soil erosion and runoff, Soil tillage and crop residue management

The soil health symposium on Tuesday dovetailed nicely with complementary topics by the ASA Soil Health Community, including a discussion session with Dr. Moebius-Clune (USDA-NRCS) and posters/presentations on parameters used to define soil health/quality/function.

Total presentations within division: 77 oral, 62 poster (totals from last year's meeting at Long Beach was 99 oral, 95 poster).
